1. INTRODUCTION

This classification report defines the classification assigned to **Avery Dennison® MPI 1405** in accordance with the procedures given in EN 13501-1:2007+A1:2009.

2. DETAILS OF CLASSIFIED PRODUCT

2.1 GENERAL

The product, **Avery Dennison® MPI 1405**, is defined as a multi-purpose film products that will be used for all kind of applications.

2.3 PRODUCT DESCRIPTION

According to the sponsor the product is composed of:

- Face film: 51 μm, high gloss polyurethane film;
- Adhesive: 25 μm, gray long term removable acrylic;
- Backing paper: Easy Apply[™] RS.

The product has a total thickness of approx. 76 μ m and a mass per unit area of approx. 100 g/m² (measured on the product).
